Motor Trend Magazine Dumps On Corvair

Chevy's rear-engine wonder recalls famous question asked in nearly every spy novel: "Could this de a case of mistaken identity?" There are legions who vehemently claim, even today. that there was simply nothing wrong with the Corvair's handling characteristics. Nor any other aspect of the car, for all that, though not everyone agrees. Radical consumerist Raiph Nader did the unthinkable by taking on GM, almost single-handedly, alleging that the Corvair was "Unsate at Any Speed" - which was also the name of his sensationalistic book on the subject. Much like the bodus "Audi Unintended Acceleration" frenzy of a decade ago, the notion caught the attention of the media and ultimately the public. After far too many legal battles. GM decided to give in, and flushed the Corvair halfway through '69.

In Motor Trend Magazine's 50th Anniversary Collector's' Edition (September 1999) they gave us the benefit of their wisdom in article entitled "Hits, Misses and Never Weres - Cars and Fads that changed our lives...or not". Trying to give us their version of the automotive industry's highlights, lowlights and nolights over the last 50 years or so.

same impact that unsalted sunflower seeds are going to have on the economy of southeastern Cochise County.


On the other had we have the group that the all-knowing people at *Motor Trend* think are the "lowlights" were a big "miss". They include:
