

Big changes coming to TCA

In the past several years the membership and activity of the Tucson Corvair Association has been dwindling. Meeting attendance is now averaging about 6 members per monthly meeting. Attendance at the activities the Club sponsors runs between 5 and 10 members per event. Membership in the past 3 years has fallen from over 40 members to below 30. Only 10 of those members regularly participating in Club gatherings/meetings and only a half dozen of those are engaged in Club leadership. These same half dozen members have been carrying this responsibility for years. It's time for some changes.

In a meeting of the Board of Directors held on May 23, several options were discussed concerning possible solutions to the dilemma we are facing. Some possible scenarios (with appropriate variations) include:

• Interested members can become members of the Classic Chevy Club of Tucson and become part of a Corvair owners group within the

club. Attend CCCT meetings and participate in CCCT activities. Dues are \$25 per year and first year's dues would be possibly paid from the TCA treasury.

- Modify TCA bylaws and reduce monthly member meetings to quarterly and have occasional activities and reduce membership dues accordingly. Participate in CCCT and Cactus Corvair activities. Newsletter would be reduced to quarterly editions.
- Dissolve TCA altogether and fellow Corvair enthusiasts can associate without the benefits/burdens of a formal organization. This would, of course, end our chapter status with C.O.R.S.A.
- Change nothing and continue as-is. This particular scenario would mean certain death to TCA since the existing leadership would soon grow tired of carrying the responsibilities of maintaining the club with little hope of improvement.

All of these options were discussed in detail as well as variations of these scenarios. The Board decided that a survey would be conducted to determine what changes members and past members would like in order to make TCA a better, more desirable club.

To that end each current member and all former member will receive a survey form by email within the next few days that can be filled out and returned for evaluation. This will greatly assist the Board of Directors in forming a plan to keep TCA alive.

It is the goal of the current Board to formulate a plan that will make TCA a better organization that fulfills the need and desires of the Tucson Corvair community.

In the 60s when the US and Cuba broke diplomatic ties, the cars that were left in the country were pretty much all anybody was going to see for many years. Parts to keep them running were difficult, if not impossible, to come by. "Regular" front-engine rear-drive cars were pretty easy to graft in another engine almost of any type or manufacturer. The poor Corvairs were left stranded. When the drive train was worn out there was no tossing some other engine in it's place without heavy modification.

Here's an example of how one clever car buff solved the problem. We don't know many details but this Corvair is equipped with a Russian Lada 4-cylinder power plant. A modified grill to allow for cooling and some fancy taillights brought this 1960 four-door back to live. Very impressive considering the circumstance.
